**NOTICE IS GIVEN** that the Public Service Commission of Wisconsin will hold a public hearing in this proceeding. There will be two separate hearing sessions, one for parties admitted to the proceeding and one for members of the public. This is a Class 1 proceeding as defined in Wis. Stat. § 227.01(3)(a).

**Party Hearing Session**

On Wednesday, March 10, 2021, at 10:00 a.m., the Commission shall receive evidence from the parties and Commission staff. This hearing has no physical location. ### **Public Hearing Session**

On Wednesday, March 10, 2021, at 2:00 p.m., and 6:00 p.m., the Commission shall receive spoken comments from the public. This hearing has no physical location. Members of the public may attend and comment by telephone, or listen live on the internet.

The Administrative Law Judge (ALJ) controls access to the hearing. Telephone lines will be muted until the time allowed for each caller to speak. Any call placed after the hearing begins will be put on hold. The ALJ will accept and mute the call at the earliest opportunity that does not disrupt the hearing. Each installment of the public hearing session will begin at the noticed start time, and continue until every caller has had an opportunity to comment.

- **Oral Comment.** Speak over the telephone during the public session. The ALJ may receive an oral comment from any member of the public in attendance after the close of any party and Commission staff testimony. The ALJ will receive an oral comment by unmuting each phone connection one at a time and inquiring into each caller’s desire to comment.
- **Mail Comment.** All comments submitted by U.S. mail shall be received no later than Tuesday, March 16, 2021. A mail comment shall include the phrase “Docket 9805-CE-100 Comments” in the heading, and shall be addressed to:

The Commission will not accept comments submitted via e-mail or facsimile (fax).

A person shall limit a public comment to non-technical personal knowledge or personal opinion. A person may include references to other materials in a comment, but may not include as part of a comment, any document not written or substantially modified by that person. The Commission shall only accept documents that a person offers to supplement a comment for the purpose of showing the basis of an opinion, not for proof of the matter asserted. Parties may object to the receipt of a public comment.

Any material submitted to the Commission is a public record and may appear on the Commission web site. Only one comment may be submitted per person during a comment period. The Commission may reject a comment that does not comply with the requirements described in this notice.
