1. CALL TO ORDER:

Town Chair David Huenink called to order the Board of Supervisors monthly meeting at 7:30pm.

2. PLEDGE OF ALLEGIANCE:

Chair Huenink led attendees in the Pledge of Allegiance.

3. CERTIFY WISCONSIN OPEN MEETING LAW HAS BEEN MET:

Clerk-Treasurer Janelle Kaiser certified that the requirements of the Wisconsin Open Meeting Law had been met. The agenda for this meeting was posted in three places within the Township and on the Town's website.

4. ROLL CALL:

5. ADOPT AGENDA AS OFFICIAL ORDER OF BUSINESS:

Motion by Lammers, seconded by Hamilton, to adopt the agenda for the January 9th, 2023 board meeting as presented; the motion carried by unanimous voice vote.

6. DISCUSSION AND APPROVAL OF MINUTES:

Motion by Stapel, seconded by Hamilton, to approve the minutes from the December 2022 board meeting as presented during the January 9th, 2023 board meeting; the motion carried by unanimous voice vote.

7. RECORD RETENTION CERTIFICATION:

Clerk-Treasurer Janelle Kaiser certified that everything is up to date.

8. PUBLIC INPUT:

a. Natasha Torry was present to discuss her candidacy for the office of Branch 2 Sheboygan County Circuit Court Judge in the upcoming 2023 Spring Election. Natasha introduced herself to the Town Board and meeting attendees and provided information about her career and involvement in the community. She also provided information about her goals and objectives if elected to the office of Sheboygan County Circuit Court Judge Branch 2. b. Chair Huenink provided follow up on the situation of Doug Inselman of N1962 State Road 32 which Doug reported at the December 2022 board meeting about an ongoing outdoor fire at N1970 State Road 32. Doug had followed the Town Board's advice from the December 2022 meeting to call emergency services and report the unattended fire. Shortly afterwards a representative of the responding fire department drove past and observed that the flames were out and only embers remained. The fire was also reported to the Sheboygan County Sheriff's Department. They contacted the property owner who then came to the site and covered the embers. Supervisor Caswell reported that he contacted a representative of the Wisconsin Department of Natural Resources (WI DNR) about the mechanical demolition of the dilapidated single-family residence on the property and alleged subsequent fire to burn the remnants of the structure following the December board meeting. The owner had previously been informed by the WI DNR that the house should be mechanically demolished and hauled away. The WI DNR has reportedly visited the property, taken photos, and will investigate the matter, but it is unlikely that the Town will receive the results of that investigation.

Motion by Caswell, seconded by Stapel, to approve the December 2022 financial/treasurer's report as presented; the motion carried by unanimous voice vote.

10. APPROVAL OF VOUCHERS:

Motion by Lammers, seconded by Stapel, to approve the January 9th, 2023 voucher listing as modified during the January 9th, 2023 board meeting; the motion carried by unanimous voice vote. A revised voucher listing will be provided in the next board meeting packet.

12. PLAN COMMISSION RECOMMENDATIONS:

- a. Matthew and Jennifer Ten Haken for a rezoning:
 - Motion by Huenink, seconded by Caswell, to accept the recommendation of the Town of Holland Plan Commission and conditionally approve the request for a rezoning by Matthew and Jennifer Ten Haken. The approval is conditional upon Sheboygan County approval and processing of the boundary line adjustment as shown in the application to the Town. County, Wisconsin; the motion carried by unanimous roll call vote.

13. ONION RIVER ELECTRICAL UTILITY UPDATE, SIGNAGE FOR UTILITY, AND POSSIBLE SIGN PERMITTING REQUIREMENTS:

Jared Stensby was present to provide a progress update about the Onion River Solar Project. He provided information about current, upcoming, and completed work on the project. Jared reported that there is continuous effort to make sure that trucks associated with the project are traveling on prescribed routes. He also reported that his team has arranged for 4-5 street sweepers running throughout the day when necessary to manage mud on the roads due to misting rain causing slippery travel conditions. Gravel will be installed on the parking area for the project on Risseeuw Road and the gates and other entrances that have been created for the project will receive another layer of gravel. Jared mentioned that the end of July or early August 2023 is the expected completion time frame for the project.
